### Tax Time is Right Around the Corner and 2-1-1 Can Help

Free tax preparation is available to households through the VITA (Volunteer Income Tax Assistance) program. VITA sites offer free tax services from mid-January through mid-April to individuals who qualify. ### Free Tax Preparation through the VITA Program (Volunteer Income Tax Assistance)

**BASIC ELIGIBILITY FOR VITA:** The VITA program is for individuals who generally make \$57,000 or less, persons with disabilities and limited English speaking taxpayers who need assistance in preparing their own tax returns. Also, individuals who are self-employed should have business expenses less than \$25,000, and individuals should not have income from a rental property.

**ONLINE VITA PORTALS:** Due to the ongoing COVID-19 pandemic, many physical VITA locations will not be open this year. But the Connecticut VITA coalitions are still offering clients an opportunity to have their taxes completed for free by an IRS-certified volunteer via a combination of an online form and the telephone. Individuals who qualify for VITA and have access to a smartphone or computer, internet/WiFi , and a valid phone number may take advantage of the online VITA options. See below for information about how to get started with VITA online in various regions of the state:

- **Hartford & Windham Counties:** Use this link to pre-register for the Virtual VITA program: <https://thevillage.jotform.com/203644662392862>. If you pre-register, you will be emailed the actual VITA link when this program opens on January 25th. Also, anyone who signs up via the pre-registration link will have their tax return given priority.
- **Fairfield, New Haven, Middlesex, New London Counties:** Information coming soon! Check back after January 19th.

### TAX ASSISTANCE BY TELEPHONE AND ONLINE

- **IRS Free File:** Taxes can also be filed for free on the IRS website: [www.irs.gov/filing/free-file-do-your-federal-taxes-for-free](http://www.irs.gov/filing/free-file-do-your-federal-taxes-for-free).
- Refund status information can be obtained four weeks after a claim has been filed, by calling, 800-829-4477. The following information must be given to obtain refund status: social security, filing status and refund amount.
- Tax assistance for people with hearing impairments and TTY equipment can be obtained by calling: 1-800-829-4059, 24 hours, Monday – Friday, 7:00am-7:00pm. People without TTY equipment may be able to obtain access through federal or state relay services.
- If an individual believes that they may have been the victim of identity theft, they should dial

## **FORMS TO BRING TO A TAX ASSISTANCE SITE**



When visiting an IRS, DRS, Tax-Aide or VITA site, bring the following:

- \* Photo ID for Caller (and/or spouse, if filing jointly)
  - \* If married filing jointly, both spouses must attend appointment
  - \* Social security cards for every member of the family (if a card is lost, the taxpayer must contact the social security administration to replace card prior to having taxes prepared)
  - \* W-2s and/or 1099's from ALL jobs worked in 2020
  - \* A check from the taxpayer's checking account or a savings account number for direct deposit (NOTE: The taxpayer can open a bank account or cash card at the tax site for direct deposit if they do not have an existing account.)
  - \* Interest statements from financial institutions (if applicable)
  - \* Tuition and student loan information (if applicable)
  - \* Documentation from daycare provider, if taxpayer paid for child care in 2020
  - \* Any other income information or IRS notices received
  - \* All 1095 forms – only if you received insurance through a federal or state marketplace or you received a 1095-A
  - \* Health Insurance Statements
  - \* Copy of last years tax return
