#### POVERTY IN CONNECTICUT

Traditionally, many have always looked at the federal poverty line to measure poverty. Connecticut is often considered one of the richest states in the union, but a closer look at the state of our economy yields a different picture. These stats help us see the true inequality that exists in our state, where we have more than 10% of residents who live below the poverty threshold. Many anti-poverty advocates use indicators such as income poverty, asset poverty, and liquid asset poverty to help provide a fuller picture of poverty across our nation.

Income poverty indicates that a household's income is lower than the federal poverty threshold. In CT, this means that 10.5% of household do not earn enough money each year to keep them above the federal poverty threshold.

The next indicator is asset poverty. Individuals or households who are asset poor may currently have enough income, but may not have enough assets or net worth to carry them through three months if a financial crisis were to occur.

#### WHAT IS ASSET BUILDING?

Asset building can be described as a strategy to help low income families increase their financial security and move up the economic ladder. Assets can be both tangible and intangible resources, such as a home, savings account, a car, investments, or a college degree.

As pointed out by Michael Sherraden, Center for Social Development, Washington University, income alone does not create financial stability. Assets are an important contributor to a family's safety net and to their ability to advance their economic future. An emergency savings account, for example, can help a family to manage through hardship events such as job loss or illness, that could otherwise result in dire consequences threatening the family's ability to meet basic needs. Assets can also help a family to take advantage of opportunities to enhance their economic status. Completing an education or training program could raise their income, or purchasing a car could increase their ability to find employment outside of their immediate environment. Additionally, a family's ability to pass on assets can help to increase the financial stability of the next generation.

A high number of Connecticut households live in liquid asset poverty, defined as not having sufficient liquid assets to subsist for three months at the federal poverty level, in the absence of income. The Corporation for Enterprise Development (CFED) publishes an annual report, the Assets and Opportunity Scorecard, that examines indicators of financial security, such as liquid assets, in the 50 states and the District of Columbia. According to the January 2015 Scorecard report, 39% of households in Connecticut live in liquid asset poverty. It is these sobering stats that have helped inform and fuel the Collaborative to work to find better and more efficient ways to help families along the path to financial freedom and wealth



building. These families are particularly vulnerable to unexpected expenses or loss of income. Federal and state policies aimed at helping poor and low income families should focus not only on income and social services, but on helping families to build their asset base.

Examples of asset building programs and services include:

- Financial education
- Financial coaching
- Free tax preparation
- Matched savings (Individual Development Accounts)
- Child Savings Accounts
- Access to public benefit programs

Although these asset building supports exist to some degree in Connecticut, they are not available and accessible to all those who can benefit from them. They are also not traditionally integrated into the workforce, income support or social service programs that touch the lives of families who experience financial instability.

Through the development of this directory the Connecticut Asset Building Collaborative aims to increase awareness of existing asset building programs, promote their connection with the greater nonprofit community, and underscore the need for the expansion of asset building supports across the state.

#### SERVICE DESCRIPTION

#### Youth IDA Program

The Youth IDA Program provides financial literacy education to students (grades 7 - 12) with the goal of teaching financial responsibility by setting savings goals and obtaining assets. The program includes a 2:1 matching savings program offering 7th and 8th graders a \$400 match for every \$200 saved and offering high school participants up to \$1,000 match for every \$500 saved during a 1 year period.

Requirements of the program include: attending Financial Education Training provided by ACCESS; attending Asset Specific Training/Savings Club (monthly); and performing at least 2 hours of community service a month (at least 20 hours/year). Open to 7th - 12th grade student in Windham Public Schools.

#### **IDA Program**

Individual Development Account (IDA) Program is a matched savings program intended to help low income families build assets and attain financial independence by purchasing a "qualifying asset." Savings will be matched 1 to 1 (up to \$4000 in matching funds). Participants can save for the purchase of their first home, post-secondary education or training, small business startup, or a vehicle to obtain employment. Clients have up to 4 years to save money and must attend a personal financial management workshop series and participate in asset-specific ownership preparation training. Child care is provided during participants' meetings. Participants must commit at least 6 months to the program. Eligible to residents of Windham County, New London County, or Tolland County; must be working; household receives assistance under TANF, or household makes 200% or below of FPL, or family's adjusted gross income does not exceed the eligibility amount for receiving the Earned Income Tax Credit (EITC): the family's net worth cannot exceed \$10,000. excluding a primary dwelling and one vehicle. No Fee.

Nationwide mentoring program helps veterans transition from the armed services to the civilian workforce through mentoring, career counseling, and networking with business and education professionals. OTHER INFORMATION: ACP offers two variations of the mentoring program: In-Person mentoring and E-Mentoring. The Mentors and Protégés in national, long-distance mentorships communicate by phone, email, and/or videoconference. ACP encourages national pairs to use videoconferencing during the first month of the mentorship to establish a personal connection. ACP expects nationally matched pairs to communicate every two weeks. ACP's programs have a limited number of openings and not all those who apply will be selected for a mentorship. Protégé applicants who demonstrate how they will benefit from a mentorship are most likely to gain acceptance. Program available to Veterans who have served on active duty since 2001 as well as the spouses of service members wounded or killed in action; veterans with service-connected disabilities will be given preference.

#### **SERVICE DESCRIPTION**

#### Family Self-Sufficiency Program (FSS)

Family Self-Sufficiency (FSS) program provides assistance to households holding a Section 8 voucher from Ansonia Housing Authority. Families agree to a program contract and work with the FSS Coordinator to achieve self-sufficiency in five years. Program components may include continuing education, specialized training, job readiness and job placement activities. When the family meets its goals and completes its FSS contract, the family becomes eligible to receive funds that have been deposited into an escrow account on its behalf throughout the family's participation in the FSS program. The amount credited to the family's account is based on increases in the family's earned income during the term of the FSS contract. The homeownership component of the FSS program allows first-time homeowners to use their Section 8 voucher subsidy to meet monthly homeownership expenses.

Residents of Ansonia; must have a Section 8 voucher issued by Ansonia Housing Authority.

Eligibility for homeownership component: Must meet any discretionary requirements the Ansonia Housing Authority establishes; must be first-time homebuyers; must not have received homeownership assistance in the past; must not have defaulted on a prior mortgage; families are required to have homeownership counseling; must meet the minimum income requirement and the employment requirement.

#### Job Finding Assistance/Job Training/Pre-job Guidance

Program offers help in enhancing interview and job seeking skills, resume development, filling out job application forms, researching job possibilities and educating the job seeker to current employment trends. Job interview trainings, job development activities and individual follow up services are also offered. Eligible to individuals ages 18+; enrolled in a substance abuse and/ or mental health treatment program in the Greater New Haven area; works with populations including recently released offenders, TANF recipients and homeless/dually diagnosed individuals.

#### Vocational Rehabilitation/Supported Employment:

Provides individuals with substance abuse disorders and/or mental health issues who face barriers to employment with specialized vocational/employment rehabilitation. Services include vocational evaluations, counseling and planning which help to identify the individual's vocational interests, skill strengths and limitations. Short term job coaching is also available for individuals who have been out of the work force for a long period of time or who need the job supports.



Family Self-Sufficiency (FSS) is a voluntary program for participants in Section 8 and public housing programs. Its purpose is to assist families receiving HUD Section 8 rental assistance or living in public housing to improve their economic situation and reduce their dependence on public assistance and welfare.

Each FSS participant creates a five-year plan that includes employment goals and identifies training or education needs. FSS staff will work with the household to identify, locate, and arrange for the services they need to accomplish their goals. Services might include child care, education, transportation, development of resumes, job training, and placement, counseling, parenting skills, money management or credit counseling.

As FSS participants succeed in raising their family income, the portion of their monthly income contributed toward their Section 8 or Public Housing rent payment also increases. HUD regulations allow a percentage of this rent increase to be deposited into an interest bearing escrow account. If the family meets its goals with the five years and "graduates" from welfare assistance for a period of 12 months, they will receive the funds in this account.

Each FSS participant creates a five-year plan that includes employment goals and identifies training or education needs. FSS staff will work with the household to identify, locate, and arrange for the services they need to accomplish their goals. Services might include child care, education, transportation, development of resumes, job training and placement, counseling, parenting skills, money management or credit counseling.

As FSS participants succeed in raising their family income, the portion of their monthly income contributed toward their Section 8 or public housing rent payment also increases. HUD regulations allow a percentage of this rent increase to be deposited into an interest bearing escrow account. If the family meets its goals within the five years and "graduates" from welfare assistance for a period of 12 months, they will receive the funds in this account.
