

# **Housing Discrimination/Fair Housing**

## WHAT IS HOUSING DISCRIMINATION

The <u>Fair Housing Act</u> prohibits discrimination based on race, color, religion, sex, disability, familial status, or national origin in housing.

The Act applies to almost all housing and housing providers in the United States, including private landlords and property management firms, property owners, federally assisted housing, public housing authorities, realtors, and lenders and insurers of housing.

It also applies to individuals, such as neighbors, who intimidate, coerce or interfere with the fair housing rights of others. The Act deals with the sale, rental or financing of housing, as well as any advertisements or statements with respect to housing.

## PROHIBITED ACTIVITIES INCLUDE

- Discrimination based on race, color, religion, sex, disability, familial status, national origin
- Refusal to sell or rent dwellings
- Imposing of different terms and conditions of sale or rental
- Falsely denying the availability of housing for sale or rental
- Refusing to make mortgage loans
- Harassing or intimidating persons exercising fair housing rights based on race, color, religion, sex, disability, familial status or national origin.
- Discrimination based on a person's source of income (see next paragraph)

# SOURCE OF INCOME

In Connecticut it is illegal to refuse to rent to a person who relies on government assistance to pay for housing. These assistance programs, known as "lawful sources of income", include: (1) Federal housing subsidies like the Section 8 housing choice voucher program, (2) State housing assistance, which includes Rental Assistance Program (RAP) and Transitional Rental Assistance Program (T-RAP), and (3) the Department of Housing (DOH) Security Deposit Guarantee Program. People living in or seeking housing in Fairfield County who believe they have been refused housing based on a landlord refusing a lawful source of income are advised to contact Connecticut Legal Services Bridgeport site for assistance.

### HOW TO FILE A COMPLAINT

Connecticut residents who have been trying to buy or rent a home or apartment and believe their rights have been violated should contact the Connecticut Fair Housing Center first. This agency will send testers to collect proof that an agency or landlord is discriminating, and they will also help with filing complaints with the appropriate state and federal agencies.
