



## How to Evaluate a Charity

Appeals for financial and material donations are solicited by countless charitable organizations. Donors who want to research a charity before donating have several options.

### **PUBLIC CHARITIES UNIT**

All charities soliciting donations from Connecticut residents are required to register with the Public Charities Unit administered by the State of Connecticut Department of Consumer Protection (DCP). Connecticut residents can call the Public Charities Information Unit at (860) 713-6170. The BBB (Better Business Bureau) Wise Giving Alliance collects and distributes information on nonprofit organizations that solicit nationally or have national or international program services. ### **CHARITY NAVIGATOR**

Charity Navigator evaluates national charities granted tax-exempt status under Section 501(c)(3) of the Internal Revenue Code and that file a Form 990. Evaluations are based on the financial status of the charities and are available to the public.
