

2-1-1 CHILD CARE

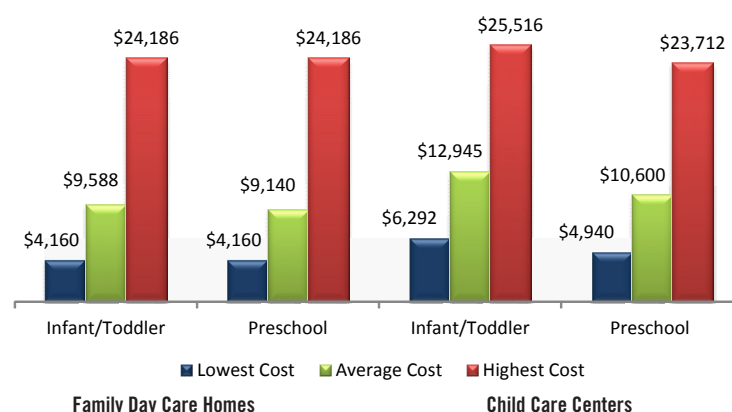
The 2-1-1 Barometer utilizes 2-1-1 data and other information to explore issues affecting Connecticut residents. 2-1-1 tracks the type of help that callers are seeking in order to create a database that serves as a barometer of the needs present in the state.



INTRODUCTION

Quality child care is essential to helping children enter kindergarten socially and academically ready to learn. Finding high quality, affordable child care is a challenge faced by many Connecticut families every day. The average cost of child care in Connecticut ranges from \$9,500 to \$13,000 for infant/toddler care and from \$9,100 to \$10,600 for preschool care (Figure 1). Costs can be even greater depending on where the family lives (Table 1). The high cost often puts child care out of reach for lower and middle income households. These households may be forced to choose between paying for care that may be inadequate and leaving the workforce to care for their children. Increasing the availability of quality child care programs is essential to helping children succeed in school and also impacts the state's economy by allowing parents to participate in the workforce.

United Way of Connecticut's 2-1-1 Child Care program helps families to find high quality child care and works with child care providers to help improve the quality of care available. This 2-1-1 Barometer reviews early care initiatives of 2-1-1 Child Care and Connecticut's United Ways and trends in child care availability as reported in a recent 2-1-1 Child Care report.

TRENDS IN CHILD CARE

The 2-1-1 Child Care Capacity and Trend Report shows a decline in the number of child care centers and a slight increase in the number of family day care homes in 2011. A five year review of data suggests that as the number of one type of facility increases, the other shows a similar decrease. These fluctuations suggest a possible relationship to Connecticut's unemployment rate; as the unemployment rate rose to over 9% in 2010, the number of Child Care Centers decreased and the number of Family Day Care Homes increased. The decrease in Child Care Centers reflects a decline in demand, while the increase in the number of Family Day Care Homes may suggest an attraction to the child care industry by the recently unemployed. 2-1-1 CHILD CARE



2-1-1 Child Care is Connecticut's official toll-free child care resource and referral service. Last year, 2-1-1 Child Care responded to 14,000 calls and recorded over 86,000 visits to its online child care search engine. 2-1-1 Child Care maintains current listings of all state licensed child care centers and family child care homes, as well as listings for nanny agencies, nursery schools, play groups and summer camp programs. There is no charge to parents who call nor is there a charge to child care programs that are listed. The database can be accessed by dialing 2-1-1 or by visiting www.211childcare.org. Chat services are also available.

SPECIALIZED PROGRAMS OF 2-1-1 CHILD CARE

In addition to maintaining a database of child care providers, 2-1-1 Child Care trains many child care providers and supports special child care projects.

Provider Orientation

2-1-1 Child Care's Provider Orientation provides information on child growth and development to unlicensed child care providers. The emphasis is on types of activities providers use for children at various ages and the strategies used to effectively guide children's behavior. Participants receive:

- Materials to support health and safety in child care: Fire extinguisher, First aid kit, Smoke detector
- Materials to support developmentally appropriate activities: Shape sorters, Puzzles, Movement ribbons, Scissors, Bi-lingual books, Nesting cups

This project also provides an opportunity to learn about the process of becoming a licensed family child care provider.



Family Child Care Career Support Project (FCCCSP)

This free service helps providers successfully start or improve their child care business. The program offers a wide range of assistance to providers including information on:

- Business Practices
- Communicating with Families
- Child growth and development
- Developmentally appropriate activities
- Routines and scheduling
- Effective environments



Over 280 licensed family child care providers have participated in the FCCCSP since it began in 2007.

Emergency Preparedness in Child Care Settings Providers

2-1-1 Child Care is collaborating with Save the Children and several state agencies to ensure that the needs and safety of children in child care settings are met in the event of an emergency, natural disaster or terrorist threat. Under the Child Care Emergency Response plan, 2-1-1 Child Care:

- Partners with Save the Children to provide disaster preparedness training to child care providers across the state.
- Maps all of the child care centers and family day care homes in the state to allow emergency personnel to identify child care facilities that are in harms ways or are near a disaster site.
- Provides a communication hub for parents in the aftermath of a disaster for family reunification.

Connecticut was the first state to work with Save the Children to develop a comprehensive disaster plan.
