

PROGRAM:	DOES APPLICANT NEED GREEN CARD OR U.S. CITIZENSHIP?
Access Health CT Plans	Longtime resident – (5-year residency) – DACA status are valid non-immigrants, but are not eligible for coverage
Burial Assistance	NO! Status is not an issue! ☺
CADAP (Ryan White)	NO! Status is not an issue! ☺
Child Care Subsidy	Yes, must have green card or citizenship
Child Support Enforcement	THE CHILD must be a citizen or have a green card. (Parents’ status does not matter.)
Community Based Services for Adults with Disabilities	Yes, must have green card or citizenship
Conn. Home Care Program for Elders	Yes, must have green card or citizenship
Elderly Nutrition	NO! Status is not an issue, ie. Meals on Wheels programs! ☺
Energy Assistance (CEAP)	Immigration status is not checked, but adult needs Social Security number to apply.
Eviction Prevention Program (EFPP)	NO! Status is not an issue! ☺
SNAP/Food Stamps	Yes, AND if person hasn’t had the green card for at least 5 years, they have to have lived in CT for at least 6 months
Healthy Start	Yes, must have green card or citizenship
HUSKY A & B	Yes/No, must have green card or citizenship (For ADULTS on HUSKY A – they also have a 5 year residency requirement) NO -(DOES NOT INCLUDE HUSKY B – Prenatal Care Coverage for pregnant undocumented individuals), & HUSKY A & B for uninsured children ages 0-12 years with no qualifying immigration status
Medicaid (HUSKY C & D)	Yes, must have green card or citizenship (For ADULTS on HUSKY A, C and D (not including pregnant women), they also have a 5 year residency requirement)
Medicaid (Emergency Services Only)	NO! For emergency medical attention only, ie. emergency room visit for critical care ☺
MSPs: QMB,SLMB,ALMB	Yes, must have green card or citizenship
Operation Fuel	NO! Status is not an issue! ☺
PCA Waiver	Yes, must have green card or citizenship
Property Tax Relief/Rebate (Elderly)	NO! Status is not an issue – Applicants must supply tax returns & social security income! ☺
Protective Services for the Elderly	NO! Status is not an issue! ☺
SAGA Cash	Yes, must have green card or citizenship
Section 8	“Mixed household” is ok. (someone in household has to be citizen or have green card)
SSD, SSI, & Soc Security Retirement	Yes, must have green card or citizenship (<i>Note for SSI: some noncitizens granted special status by the Department of Homeland Security may be eligible</i>)
State Supplement	Yes, must have green card or citizenship
Summer Food/Meals (End Hunger)	NO! Status is not an issue ☺
TBI Waiver	Yes, must have green card or citizenship
TFA	Yes, must have green card
WIC	NO! Status is not an issue! ☺
